

TERMS & CONDITIONS OF ENTRY AND SALE OF PAINTINGS

PLEASE READ ALL THE TERMS & CONDITIONS CAREFULLY!

1. **ENTRIES** – Entry to this Awards Exhibition is restricted to current members of the member Societies of the Combined Art Societies of Sydney Inc. A current list of member societies is available at <http://combinedartsocieties.com/members/>

Eligible artists may submit a maximum of four (4) paintings each one up to 310cm outside perimeter of the frame, or deep edge canvas – OR one of those four paintings can be oversize to a maximum of 410cm but without glass as part of the framing.

2. SECTION REQUIREMENTS FOR MEDIUM AND SUBJECT:

Section 1. Landscape, rural and urban. May be framed or deep edged canvas. ANY MEDIUM.

Section 2. Marine Subject - must be related to water above or below. Lakes, rivers, beaches, ocean etc.
ANY MEDIUM

Section 3. Still Life – Flora and Fauna ANY MEDIUM

Section 4. Figurative. ANY MEDIUM

Section 5. 9"x 5" – Any subject, image size must measure exactly 9" x 5" – ANY MEDIUM any subject

Section 6. Miniature Paintings – Any subject. Any medium

The perimeter of the actual artwork must not exceed 40cm

(eg. 10cm x 10cm), or any variation of this size. Must be framed, outside perimeter of the frame to be no larger than 120cm.

Two (2) Miniatures will be accepted for one Entry Fee and counted as one Entry.

3. PAINTING SELECTION –

Paintings will be selected via a clear correct image with title and section, sent to our webmaster of the painting only, no frame showing – to

karin@ozartfinder.com as soon as possible after you have sent in your entry form.

Artists will be advised on what paintings have been accepted in January 2026.

4. DELIVERY OF ACCEPTED PAINTINGS THE VENUE –

Delivery of accepted paintings will be on Monday 2nd February 2026 between 9am – 12noon at the Bayview Room, St. George Motor Boat Club, 2 Wellington Street, Sans Souci.

5. NUMBER, PRICE AND SIZE OF WORKS

Each artist may submit a total of 4 artworks. **Maximum size perimeter of 310cm** will be accepted. This measurement is obtained by measuring around the edge of the frame on the painting, or, in the case of unframed canvas the outside edge of the canvas. **There is a maximum of only ONE (1) LARGE PAINTING per artist.** Size of your large work will include a painting with a perimeter of up to 410cm. Artists may enter one large artwork. **NOT UNDER GLASS.**

6. FRAMING

Exhibits must be dry and properly framed. To maintain the standard of excellence in this exhibition, poorly framed works will not be considered for judging or inclusion in the exhibition. Only non-metallic frames with soft cord or plastic coated wire, . **All metal on the back of your painting, including staples, must be covered.** *Please make your framer aware of these conditions and the size restrictions.*

7. DEEP EDGE CANVASES – artworks must be dry and may be entered unframed on Deep Edge 38mm (1½")

artist quality stretched canvas, professionally stapled at the back. Staples on the side of the canvas will not be accepted. It is desirable that each deep edge canvas be fitted with a backing board, but the decision to do this is that of the artist - **the CASS will take no responsibility for damaged canvases.** Sides of the canvas must be painted thoroughly, cleanly and neatly. **Narrow edged canvases, regardless of size and shape, must be framed. Unframed, narrow-edge canvases will not be accepted. Only paintings that are professionally stapled and soft hanging cords, or 'plastic coated' wire, will be accepted.**

8. **ORIGINALITY** – Entries must be the original work of the artist and must not have been entered in any previous Art of Sydney Awards Exhibition. Copies of any other person's work or paintings produced in workshops will not be eligible for judging or inclusion.
9. **ENTRY FEES** – A non-refundable entry fee of \$20.00 will apply for each exhibit entered.
10. **ENTRIES CLOSE** – 24th November 2025.
11. **RESUME** – Artists are asked to include a current **A4 size** resume with their work to include in the CASS Resume folder for viewing by the public during the exhibition. To be brought with work on the take in day
12. **IDENTIFICATION OF PAINTINGS** – All entries must be clearly labeled on the back. **Affix the labels provided to the BOTTOM right hand corner at the back of each painting** - when the painting is face down.
- Title, Medium and Price
 - Section for entry
 - Name of artist
 - Name of the Society to which the artist belongs
13. **COMMISSION** – 25% commission will be charged on all sales. A donation will be made to CareFlight once the exhibition is over. All works entered must be for sale.
14. **GST COMPLIANCE** – At the time of printing this form, CASS is not registered to collect GST. Therefore, as an artist, if you are registered for GST, please include the 10% GST in your listed price, and CASS will pay the relevant amount of GST to you along with any money owing to you from sale of paintings.
15. **WITHHOLDING TAX** - The Australian Taxation Department requires CASS to withhold 48.5% of money owing to an artist as a result of a painting being sold unless the artist has quoted an ABN, or is a hobbyist as defined under the Act. Please ensure you have completed the Artist's Declaration in full on the Entry Form and **include a "Statement by Supplier" Form if you are claiming to be a Hobbyist.**
16. **INSURANCE** – The Combined Art Societies of Sydney Inc will take all reasonable care with all exhibits submitted, but will not be responsible for loss of, or damage to, any such work while in their custody, nor for insurance of exhibits either in transit or on exhibition. Exhibitors requiring insurance should make their own arrangements in regard to this matter.
17. **DELIVERY** - All Artists are responsible for delivery of their paintings on **Monday 2nd February 2026, 9am to 12noon**. Entries must be delivered to CASS free of charges to the Bayview Room, St. George Motor Boat Club, 2 Wellington Street, Sans Souci. No payments will be made by the CASS committee for freight or other fees incurred during delivery and /or return of paintings.
18. **PAINTINGS WHEN DELIVERED** – on **Monday 2nd February 2026 will be inspected for size, correct information & condition and quality of the framing. AND COULD BE REJECTED IF THEY DO NOT REACH THE STANDARD**
19. **HANGING** will take place on **Monday 2nd February 2026 between 11am and 8pm.**
20. **JUDGING** – will take place on **Monday 2nd February 2026, from 3pm to 8pm.**
21. **COLLECTION OF ARTWORKS** – **will be between 6pm and 8pm on Thursday 5th February 2026** – Unsold paintings are to be picked up by individual artists. Paintings may not be removed from the Exhibition by the artists prior to the closing of the exhibition.
22. **PUBLICITY** – The committee reserves the right to allow reproduction by the CASS, the media or TV, and the CASS official photographer, of any entry accepted for hanging.
23. **ROSTER** - **It is a Condition of Entry** that exhibiting artists volunteer sometime to assist during the course of the Exhibition.

IMPORTANT – *please be aware that the Art of Sydney Exhibition would not be available to our CASS members were it not for the volunteers from our Societies who agree to 'give a hand' to help with the proceedings that will ultimately see our paintings on show to the public.*
